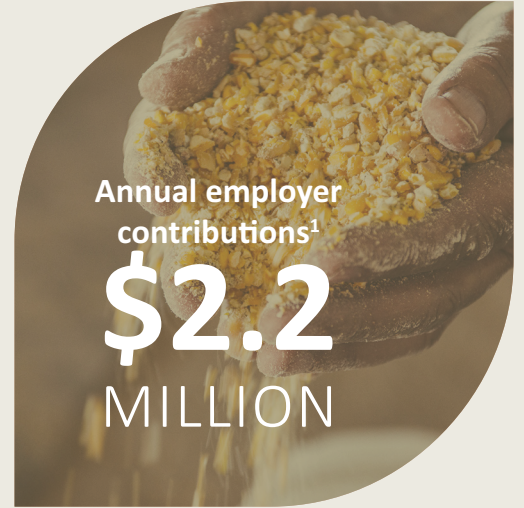


# Your Pension Plan Financial Update

This information provides you with a high-level update on the financial condition of the **Ninth Farm Credit District Pension Plan** (Pension Plan).

<sup>1</sup>Annual employer contributions and investment gains fund the total cost of the Pension Plan. Neither employees nor retirees are required to contribute to the Pension Plan. Contributing employers are: AgVantis Inc, American AgCredit FLCA, Farm Credit of Southern Colorado, Western Kansas Farm Credit FLCA, Farm Credit of Western Oklahoma, Frontier Farm Credit FLCA, Golden State Farm Credit PCA, High Plains Farm Credit FLCA, Oklahoma AgCredit and Premier Farm Credit FLCA.

<sup>2</sup>Market value, the amount of money available to pay benefits and reasonable plan expenses, is \$274.3 million as of Dec. 31, 2024.

<sup>3</sup>Market-based funded status (ratio) is equal to the market value of assets divided by the market-based liability. Pension Plan assets are held in trust for the sole purpose of paying benefits to plan participants, beneficiaries and plan expenses. Participating employers are responsible for funding the plan, which is a government plan not subject to the Pension Benefit Guaranty Corporation.

<sup>4</sup>Plan participants as of Dec. 31, 2024: 37 active employees, 280 retirees receiving benefits, 25 former employees entitled to a future benefit.
